PENNSYLVANIA STATE USBC MASTERS TOURNAMENT

GENERAL RULES – REGULATIONS – INFORMATION

Certified by the United States Bowling Congress

1. This is a one-day singles tournament open to USBC members certified within the State of Pennsylvania. Any non-Pennsylvania resident must purchase a card within Pennsylvania and have a minimum of a 12-game average in a current league certified with a Pennsylvania Association. Participants will be governed by the rules of the USBC, plus the following.
2. Entry fee is \$125.00 (\$100.00 prize fund, \$25.00 lineage). All paid and completed entries will be accepted on a first-come, first-served basis until the entry closing date or until the maximum number of entries is received. The advance closing date is February 23, 2024. If lanes are available, late entries will be accepted up to one (1) hour prior to qualifying squad, with an additional fee of \$20 (to be added to the prize fund). All others will be placed on a waiting list in order of receipt. Any checks returned from the bank will be subject to a \$35.00 service charge.
3. TOURNAMENT FORMAT will be as follows:
 - a. Qualifying First Round: All entrants will bowl at 10:00 a.m. on Saturday, March 8th. The qualifying round will be held to determine the top 25%, who will then advance to the semi-finals. Each bowler will bowl five (5) games across ten lanes. This five-game total will be used to qualify and carry over for the semi-finals.
 - b. Semi-finals: The semi-finals will be held to determine the top five (5) high qualifiers. Each bowler will bowl three (3) games across six lanes. This three-game total added to the qualifying total will determine the position of the five (5) finalists for the stepladder finals.
 - c. Finals: The five (5) finalists will compete in one game matches in stepladder fashion on one pair of lanes to determine the tournament champion.
4. Participants may not practice in the tournament center on the day of the tournament.
5. All participants are to check in at the tournament office at least 45 minutes prior to qualifying squad time and must present their current USBC Membership Card. Failure to comply with this provision is cause for the Tournament Director to fill that position with a player from the waiting list. A bowler thus removed will be placed at the head of the waiting list. Anyone not present and ready to bowl at the start of any squad will receive a score of zero for each frame missed.
6. All participants will be allowed 10 minutes of practice for the qualifying round and 5 minutes for the semi-finals.
7. If the final position in either the qualifying or semi-final rounds should result in a tie, a one game roll-off will be held to break the tie. In the event a tie still exists after the one game roll-off a 9th and 10th frames will be bowled until the tie is broken. If a tie exists within the seeding of the top five finalists for the step ladder finals, the highest game from the 8 games of qualifying will determine the higher seed. During the step ladder finals, if there is a tie a 9th and 10th frames will be bowled until the tie is broken.
8. If the final position in any round should result in a tie, one game will be bowled immediately after completion of the round. In the event a tie exists after this match, 9th and 10th frames will be bowled until the tie is broken. If a tie exists in seeding for the step ladder finals, high game from the 8 games of qualifying will break the tie. For the step ladder finals, if there is a tie a 9th and 10th frames will be bowled until the tie is broken.
9. Participants are requested to wear suitable attire for the PA State USBC Masters Tournament. All shirts and blouses must cover the shoulders. Attire that is not suitable – bare midriffs, workout attire, short shorts, short skirts/skorts, any clothing with offensive language/images.
10. The prize fund shall be returned 100%. The prize ratio is at least 1 in 4. The top 25% will at least receive their entry fee.
11. After an entry fee has been accepted, I can neither sell nor transfer it. If I am unable to bowl, I will notify the PA State USBC office in writing, 24 hours prior to the start of the tournament. PA State USBC, at its option may permit the next person on the waiting list to participate in the tournament. If a paid replacement is secured the original entrant will receive a refund. If no replacement is secured, entrant will forfeit entry fee paid.
12. Over 50 side pot: \$20 entry fee, 1:5 cash, total pins from the qualifying round.
